This policy helps you to protect the financial future of those you care for.

You can claim on this policy if you die or if you suffer a critical condition or total and permanent disability or become unable to work.

## Your Pinnacle Life Policy

Welcome to Pinnacle Life. We are a New Zealand life insurance company, and we operate from our office in Auckland, New Zealand.

This policy document sets out the terms of your policy with us. We want you to feel certain about the cover you have and how to make changes to it. Some words have an asterisk\* after them. These words have a specific meaning in this policy; you can find the meanings in the list of definitions. After you have read this document, please keep it somewhere safe.

### Your insurance cover

'you', the policy owner	You, <a href="#">Sarah Sample</a> and <a href="#">Sam Sample</a> are the policy owners. As policy owners, you are the only people who can authorise changes to this policy. We'll pay the proceeds of any claim under this policy to you or your estate, or your nominated beneficiary*.
the first insured person*	The first insured person* under this policy is <a href="#">Sarah Sample</a> , a <a href="#">male</a> , born <a href="#">05 June 1985</a> , living in <a href="#">New Zealand</a> , insured as a <a href="#">non-smoker</a> *. When you applied for this policy the first insured person's* usual occupation* was identified as <a href="#">Secondary School Teacher</a> . Cover for <a href="#">Sarah</a> includes: <ul style="list-style-type: none"><li>• <a href="#">\$500,000</a> Life Cover</li><li>• <a href="#">\$25,000</a> Critical Conditions Cover</li><li>• <a href="#">\$25,000</a> Total and Permanent Disability Cover</li><li>• <a href="#">\$4,250</a> Income Protection Cover per month.</li></ul> Each of these covers is explained under its cover heading on the following pages.
the second insured person*	The second insured person* under this policy is <a href="#">Sam Sample</a> , a <a href="#">female</a> , born <a href="#">05 June 1987</a> , living in <a href="#">New Zealand</a> , insured as a <a href="#">non-smoker</a> *. When you applied for this policy the first insured person's* usual occupation* was identified as <a href="#">Secondary School Teacher</a> . Cover for <a href="#">Sam</a> includes: <ul style="list-style-type: none"><li>• <a href="#">\$500,000</a> Life Cover</li><li>• <a href="#">\$25,000</a> Critical Conditions Cover</li><li>• <a href="#">\$25,000</a> Total and Permanent Disability Cover</li><li>• <a href="#">\$4,250</a> Income Protection Cover per month.</li></ul> Each of these covers is explained under its cover heading on the following pages.
your cover start date	Your cover starts on <a href="#">07 October 2024</a> provided that we receive your first payment by <a href="#">21 October 2024</a> . Otherwise, the cover will start when we receive your first payment. If we do not receive your first payment by <a href="#">07 November 2024</a> , this offer will expire, and you will need to reapply.
your payments	Your payment is <a href="#">\$165.12</a> per month. This includes: <ul style="list-style-type: none"><li>• A discount of <a href="#">\$20.64</a> per month for the first 12 months because you applied online.</li><li>• A discount of <a href="#">\$20.64</a> per month because of <a href="#">Sarah and Sam's</a> excellent health and lifestyle when the policy was first issued.</li></ul> We'll increase your payments on <a href="#">01 November</a> each year. The increase covers the insured person's* increasing age plus the annual CPI* (Consumer Price Index*) increase (unless you have

chosen to stop CPI\* increases).

Your first increase will be effective on [01 November 2025](#).

There is no GST to be paid on Life Cover, but GST applies to Critical Conditions Cover, Total and Permanent Disability Cover and Income Protection Cover. This is included in your payment.

If you pay by credit card there will be an additional charge of 3.95%.

If we pay a claim on the Critical Conditions Cover or Total and Permanent Disability Cover your payments will be recalculated based on the amount of remaining cover. We'll notify you of your new payment amount as soon as possible after we have paid the claim.

#### your policy ends

This policy will end on the day:

- we pay out a claim for the full amount of the Life Cover for an insured person\*, or
- you cancel your policy, or
- you have stopped making payments and aren't receiving the financial hardship benefit, or
- the maximum amount of cover has been paid to you as a claim on another Pinnacle Life policy, on your Critical Conditions Cover or on your Total Permanent Disability Cover.

Please also check 'your cover ends' under each cover heading for further information and any earlier end dates.

If this policy ends while one of the insured persons\* is still covered, we'll continue to insure that person under a new policy, subject to the payment of premiums, and other policy terms, such as maximum ages for insured benefits. If this happens, we'll issue you a new policy and send it to you at your last known contact address.

## Your Life Cover

Life Cover provides a one-off payment in the event of an insured person's\* death or diagnosis with a terminal illness

who is covered	<p><a href="#">Sarah Sample</a> is insured for <b>\$500,000</b> Life Cover.</p> <p><a href="#">Sam Sample</a> is insured for <b>\$500,000</b> Life Cover.</p>
what is covered	<p>We'll pay you the insured person's* Life Cover amount as a lump sum if they:</p> <ul style="list-style-type: none"><li>• die, or</li><li>• are diagnosed by a doctor* or medical specialist* with a terminal illness where life expectancy, after taking into account all reasonable available treatment, is 12 months or less whichever occurs first.</li></ul>
what is not covered	<p>We won't pay your Life Cover (or any other benefits associated with your Life Cover) if the insured person's* death or terminal illness results from:</p> <ul style="list-style-type: none"><li>• suicide or self-inflicted injury, if it occurs on or before <a href="#">07 November 2025</a> (13 months after the start date of your policy), or</li><li>• occurs while the policy is suspended.</li></ul>
your Life Cover ends	<p>As long as you continue making your payments, your Life Cover ends on the day we pay out the full amount of the Life Cover for an insured person* under this policy.</p>

## Other benefits associated with your Life Cover

There are other benefits included with your Life Cover.

<p><b>Funeral Support Benefit</b></p>	<p>A \$15,000 Funeral Support early payment benefit.</p> <ul style="list-style-type: none"> <li>• This benefit will be paid to your nominated beneficiary* when we receive written notification of your death.</li> <li>• If you do not have a nominated beneficiary*, we will pay the surviving policy owner if there is one.</li> <li>• We will deduct the amount paid from any later payment of your Life Cover.</li> <li>• If your Life Cover claim is not approved, the Funeral Support Benefit payment will need to be refunded to us.</li> </ul> <p>The Funeral Support Benefit is not payable if you have not nominated a beneficiary* and are the sole policy owner (as there is no surviving policy owner).</p>
<p><b>Child Funeral</b></p>	<p>We'll pay \$10,000 if an insured person's* biological or legally adopted* child aged 18 years or under dies.</p> <ul style="list-style-type: none"> <li>• This benefit is only payable to the policy owner.</li> <li>• For each child's funeral, we'll only pay the benefit once even if you have multiple policies with us.</li> <li>• Once you've claimed on this benefit once, this benefit will cease.</li> </ul>
<p><b>Financial Planning</b></p>	<p>After you've made a Life Cover claim, you can claim for reimbursement of any fees up to a maximum of \$3,000 (including GST) for:</p> <ul style="list-style-type: none"> <li>• financial planning advice that you receive from a licensed Financial Advice Provider; and</li> <li>• legal advice you receive from a Lawyer, with a Practising Certificate, relating to financial planning.</li> </ul> <p>You must claim this benefit within one year of the Life Cover claim being paid out.</p> <ul style="list-style-type: none"> <li>• Receipts are required to prove the cost of the financial planning.</li> <li>• There will be only one payment made for each insured person*.</li> </ul>
<p><b>Counselling</b></p>	<p>After you've made a Life Cover claim and have received a referral by a registered doctor* or medical specialist*, we will reimburse up to \$2,500 per claim toward the cost of consultations with a:</p> <ul style="list-style-type: none"> <li>• counsellor (registered with the New Zealand Association of Counsellors),</li> <li>• psychologist, (registered with the New Zealand Psychologists Board) or</li> <li>• psychiatrist (registered with New Zealand Medical Council)</li> </ul> <p>The counselling must be for:</p> <ul style="list-style-type: none"> <li>• the insured person* and/or close relative of the insured person*</li> <li>• the support treatments and/or consultations directly related to a Life Cover claim.</li> </ul> <p>The consultation and/or counselling must be paid for within three months.</p> <ul style="list-style-type: none"> <li>• Receipts are required to prove the cost of consultations.</li> <li>• There will be only one payment made for each insured person*.</li> </ul>

## Your Critical Conditions Cover

Critical Conditions Cover is an early payment benefit; if you claim for a Critical Condition, the insured person's\* Life Cover will be reduced by the amount paid

<p><b>who is covered</b></p>	<p><b>Sarah Sample</b> is insured for <b>\$25,000</b> Critical Conditions Cover.</p> <p><b>Sam Sample</b> is insured for <b>\$25,000</b> Critical Conditions Cover.</p>
<p><b>what is covered</b></p>	<p>We'll pay you the insured person's* Critical Conditions Cover the first time they suffer from one of the following 38 Critical Conditions at the level of severity or in the manner outlined in the definitions:</p> <ul style="list-style-type: none"> <li>• accidental HIV infection (medically or occupationally acquired)</li> </ul>

- advanced diabetes (with at least one complication of specified severity)
- Alzheimer’s disease
- aplastic anaemia
- benign tumour of the brain or spinal cord (with permanent neurological impairment or requiring specified treatment)
- blindness (severe and permanent)
- cancer (excluding specified early-stage cancers)
- cardiomyopathy – severe and permanent
- chronic kidney failure – with specified treatment
- chronic liver failure
- chronic lung failure
- coronary artery bypass graft surgery
- dementia with significant cognitive impairment
- encephalitis - with permanent neurological impairment
- heart attack
- heart valve surgery
- idiopathic Parkinson’s disease
- invasive meningococcal disease – with significant, permanent functional impairment
- intensive care treatment – requiring specified treatment and length of stay
- loss of hearing in both ears (profound and permanent, including requiring cochlear implant)
- loss of limbs – total and permanent
- major burns - of specified severity and requiring specified treatment
- major head trauma resulting in permanent and significant neurological impairment
- major organ transplant surgery
- motor neurone disease
- multiple sclerosis – with specified severity
- muscular dystrophy
- out of hospital cardiac arrest - unrelated to a medical procedure
- paralysis – total and permanent
- pneumonectomy
- pulmonary hypertension (idiopathic and familial) – of specified severity
- severe rheumatoid arthritis - with specified treatment
- stroke - in the brain resulting in specified impairment
- systemic lupus erythematosus – with confirmed lupus nephritis of specified severity
- severe systemic sclerosis
- thoracic or abdominal aorta (excluding its branches) repair– with specified treatment
- triple vessel angioplasty
- total and permanent loss of speech

This lump sum will be an early payment of the insured person’s\* Life Cover. This means that;

- if we pay your Critical Conditions claim, then that insured person’s\* Life Cover will be automatically reduced by the amount paid.
- if, at that point your Total and Permanent Disability Cover is more than your Life Cover, your Total and Permanent Disability Cover will also be reduced.

what is not covered

We won’t pay any Critical Conditions claim, if:

- the insured person\* dies within 14 days of suffering the Critical Condition, or
- the Critical Condition occurs while the policy is suspended, or
- the Critical Condition results from intentional self-injury, or
- the Critical Condition or symptoms, occur on or before [21 October 2024](#)

your Critical Conditions Cover

Your entitlement to receive a Critical Conditions claim payment for an insured person\* will end on the earlier of:

ends

- the last day of the month in which the insured person\* turns 70, being [30 June 2055](#) for [Sarah](#) and [30 June 2057](#) for [Sam](#), or
- on the day we pay that insured person's\* Critical Conditions claim, or
- on the day that we pay that insured person's\* claim on another Pinnacle Life policy if the claim amount is the same as the maximum amount of cover.

We'll only ever pay one Critical Conditions claim for each insured person\*.

## Your Total and Permanent Disability Cover

Total and Permanent Disability Cover is an early payment benefit; if you claim for a Total and Permanent disability\*, the insured person's\* Life Cover will reduce by the amount we have paid.

who is covered	<p><a href="#">Sarah Sample</a> is insured for <b>\$25,000</b> Total and Permanent Disability Cover.</p> <p><a href="#">Sam Sample</a> is insured for <b>\$25,000</b> Total and Permanent Disability Cover.</p>
what is covered	<p>We'll pay you the insured person's* Total and Permanent Disability Cover the first time they meet the definition of Total and Permanent disability*.</p> <p>This lump sum will be an early payment of the insured person's* Life Cover. This means that:</p> <ul style="list-style-type: none"><li>• if we pay your Total and Permanent Disability claim, then that insured person's* Life Cover will be automatically reduced by the amount paid.</li><li>• If, at that point, your Critical Conditions Cover is more than your Life Cover, we will reduce your Critical Conditions Cover.</li></ul>
what is not covered	<p>We won't pay the insured person's* Total and Permanent Disability claim if the event causing the insured person's* disability:</p> <ul style="list-style-type: none"><li>• occurs while the policy is suspended, or</li><li>• results from intentional self-injury, or</li><li>• occurs before the date on which this policy was first issued.</li></ul>
your Total and Permanent Disability cover ends	<p>Your Total and Permanent Disability Cover* will end on the earlier of:</p> <ul style="list-style-type: none"><li>• the last day of the month in which that insured person* turns 65, being <a href="#">30 June 2050</a> for <a href="#">Sarah</a> and <a href="#">30 June 2052</a> for <a href="#">Sam</a>, or</li><li>• the day we pay that insured person's* Total and Permanent Disability claim, or</li><li>• the day that we pay that insured person's* claim on another Pinnacle Life policy if the claim amount is the same as the maximum amount of cover.</li></ul> <p>We'll only ever pay one Total and Permanent Disability claim for each insured person*.</p>

## Income Protection Cover

Income Protection replaces your income with a monthly payment if you become sick or disabled and can't work. This is a standalone cover, so any payment for Income Protection will not affect your Life Cover amount.

who is covered	<p><a href="#">Sarah Sample</a> is insured for <b>60%</b> of their monthly income*, with a cover limit of <b>\$4,250</b> per month.</p> <p><a href="#">Sam Sample</a> is insured for <b>60%</b> of their monthly income*, with a cover limit of <b>\$4,250</b> per month.</p> <p>Your cover limit can be found in the 'who is covered' section.</p>
what is covered	<p>We'll replace <a href="#">Sarah Sample</a>'s income with a monthly payment that's equal to <b>60%</b> of their monthly income*. <b>60%</b> was the amount selected when you applied for the policy. The maximum payment will be the cover limit.</p>

We'll replace **Sam Sample's** income with a monthly payment that's equal to **60%** of their monthly income\*. **60%** was the amount selected when you applied for the policy. The maximum payment will be the cover limit.

The person nominated as the Income Protection beneficiary\* will receive the benefit payments. When your policy is first issued, you, the policy owner, are automatically nominated as the Income Protection beneficiary\*.

Any other income received by the insured person\*, or any income they are entitled to, will be considered and the amount deducted from their monthly payment. This includes any income from any type of work (either full or part-time), or sick leave, other insurance policies, ACC\* or payments from any other government agency.

If the insured person\* is overseas for more than three months while receiving payments for Income Protection, their monthly payments will stop until they return to New Zealand.

#### **Your waiting period (how long before we'll start paying)**

The waiting period starts from the day the insured person\* becomes unable to work\*, provided that they remain unable to work\* for the entire waiting period.

- The waiting period you selected is **60 days** for **Sarah** and **60 days** for **Sam**.
- We'll start making monthly payments on the last day of the month after the waiting period has passed.

#### **Your cover period (how long we'll keep paying for)**

Provided that the insured person\* remains unable to work\*, we'll continue making payments for

- the period you selected, which is **12 months** for **Sarah** and **12 months** for **Sam** or,
- until the end of the month in which the insured person\* turns 65, whichever occurs first.

Your cover limit can be found in the 'who is covered' section.

#### **what is not covered**

We won't pay an Income Protection claim under this policy if the claim was directly or indirectly contributed to or caused by any of the following:

- the use of drugs, unless taken as prescribed by a doctor\*
- participation in an unlawful act, including driving with excess blood alcohol levels
- a self-inflicted injury
- a suicide attempt
- a mental illness\*
- the insured person\* failing to follow reasonable medical advice to prevent, minimise or recover from the illness or injury that caused them to be unable to work\*
- normal pregnancy (including participation in an IVF or similar program, normal discomforts such as morning sickness, backache, varicose veins, ankle swelling or bladder problems), giving birth, miscarriage or termination of a pregnancy
- being made redundant\*
- an act of war, civil war, terrorism, invasion, strike, riot, civil commotion, rebellion, revolution, insurrection, hostilities, military coup or usurped power, either within New Zealand or when travelling abroad.

In addition, we won't pay a second claim for an illness or injury if the second claim is related to or is a recurrence of an earlier claim and the insured person has not been in continuous\*, full time\*, paid employment in New Zealand for at least 4 months since the initial claim ended.

Your Income Protection Cover will end:

- on the last day of the month in which that insured person\* turns 65, being **30 June 2050** for **Sarah** and **30 June 2052** for **Sam**, or
- if that insured person\* dies
- if your policy ends for any other reason.

Your cover will not end when a claim is made as you are entitled to make multiple claims under this cover.

## Payment

Information about your payments, such as how we calculate your payments and your options for how to pay

calculating your payments	<p>We base your payment amount on:</p> <ul style="list-style-type: none"><li>• the type of cover you have</li><li>• your amount of cover</li><li>• the waiting period you select (for Income Protection)</li><li>• the cover period you select (for Income Protection)</li><li>• the insured person's* gender, smoking habits and declared state of health</li><li>• the insured person's* occupation and pastimes.</li></ul> <p>Each year, on the anniversary of your policy, we'll automatically increase your payments. This reflects the insured person's* increasing age plus the annual CPI* increase to your cover (unless you have chosen to stop CPI* increases or you are no longer eligible for CPI*, see the section entitled 'increase your cover for inflation'.) CPI* increases will stop if your cover limit reaches the maximum amount of cover allowed.</p> <p>We'll notify you at least 20 days before a price increase.</p> <p>If the insured person's* state of health deteriorates from year to year, it has no impact on what you pay.</p> <p>If you reinstate your policy, we will review any changes to your health and this may affect the price. Your cover limit can be found in the 'who is covered' section.</p>
which currency	All transactions are in New Zealand dollars.
payment frequency and due date	<p>Your payments follow a monthly cycle. They are due by the 25th of each month to pay for the following month's cover.</p> <p>Depending on the day you apply, your first two payments may be as little as one week apart or as much as five weeks apart.</p> <p>As an alternative, we can offer a six-monthly or an annual payment cycle. Contact us to arrange this.</p>
when you don't need to make your Income Protection payment	<p>If an insured person* is made redundant* from their usual occupation*, we'll waive the portion of your monthly payments to us that relate to that insured person's* Income Protection Cover. We'll waive these payments until the insured person* resumes working, provided that:</p> <ul style="list-style-type: none"><li>• the insured person* was not self-employed, and</li><li>• they were made redundant* at least 90 days after the cover start date, and</li><li>• they were unaware they were likely to be made redundant* before the cover started.</li></ul> <p>The maximum period we will waive your payment is six months in any two-year period.</p> <p>The insured person* is eligible to claim on the policy during this period.</p>
payment methods	You can pay by direct debit or credit card. You can switch between payment methods at any time. To pay by direct debit, you'll need a New Zealand bank account. Simply complete and return the direct debit form that you can download from our website.
additional bank charges	There are no extra charges if you pay by direct debit. If you pay by credit card, you'll pay an additional fee of 3.95%. If you pay in a currency other than New Zealand dollars, your bank may



charge an additional fee for exchanging your currency.

#### payment holiday for financial hardship

You can apply to us in writing to ask us for a payment holiday for up to 12 consecutive months. This means you won't need to make any payments, but no cover will be provided. This means you won't be able to claim for any condition or event that occurs, or is first diagnosed during the payment holiday, even if this would normally be covered under your Critical Conditions, Total and Permanent Disability or Income Protection covers.

At any time during that 12-month period you can reinstate your policy on the existing terms without having to reapply.

The payment holiday is only available if you are experiencing financial hardship. This includes:

- redundancy\*
- bankruptcy
- tertiary studies
- overseas travel
- leaving paid employment to become a full-time caregiver for partner or child
- death of a spouse, partner, or child
- natural disaster where the event affects an insured person's\* ability to work
- employer approved leave without pay or
- any other event Pinnacle Life agrees to, at its sole discretion.

To apply for the payment holiday, we'll need evidence to support your application.

From the date you reinstate this policy or after 12 months of the payment holiday, payments will be payable on the same terms that applied before the payment holiday. We'll base the payments on the insured person's\* current age and the premium rates that apply at that time.

We won't approve your application for a payment holiday unless you have paid at least four monthly payments by the payment date since your last payment holiday ended. Over the life of the policy, the payment holiday can only be used for a maximum of 24 months.

If your policy has lapsed due to non-payment (missing four payments in 24 months), you are not able to use the payment holiday to reinstate your policy. You must apply for a payment holiday before the 4th payment is missed.

#### cover suspended for non-payment

We should receive your monthly payment on or before the 25th of each month. If we haven't received your payment by the 1st of the next month, we'll immediately put your cover on hold (suspend your cover).

If we suspend your cover we'll:

- notify you of the suspension at your last known contact address
- not pay any claim relating to a period in which cover was suspended
- restart your cover in the month following your next payment.

#### cover ended for non-payment

If you miss three of your monthly payments within a 24-month period without catching them up, your policy will end the next time you miss a payment. The three monthly payments don't need to be consecutive. If this happens:

- we'll notify you at your last known contact details
- your cover will stop on the 1st of the month following the last due date missed
- we won't refund any payments you have made to date.

## Changes

[Changes you can make to your policy and how to go about making those changes](#)

change policy owner	When your policy is first issued, you are automatically both the policy owner and the insured person*. You can change the owner of your policy to someone else at any time. To change the owner, complete the change of ownership form attached to this policy document. You can also find the change of ownership form on our website.
change beneficiary*	When your policy is first issued, the policy owner will automatically be the beneficiary* of the policy. You can change the beneficiary* for your Life, Critical Conditions and Total and Permanent Disability Cover by completing a change of beneficiary* form. You can find the change of beneficiary form on our website.
change Income Protection beneficiary*	The person to whom we'll pay an Income Protection claim is called the Income Protection beneficiary*. When your policy is first issued, any insured person* with Income Protection Cover will be their own Income Protection beneficiary*. You, the policy owner, can apply at any time to change the Income Protection beneficiary* to someone else by completing a 'change of beneficiary' form. This form is available on request from us, or it can be downloaded from our website.
increase your cover for inflation	<p>Each year on the anniversary of your policy, we'll automatically increase your cover. This helps your policy to keep up with the pace of inflation. We'll base the increase on the Consumer Price Index* (CPI*) published by Statistics New Zealand in September of each year.</p> <p>To stop the next CPI* increase, just tell us in writing before your next policy anniversary.</p> <p>We don't offer the CPI* increase if you have previously claimed (or are eligible to claim) under this policy OR if a loading* of more than 125% has been applied to your policy as a result of an insured person's* state of health. CPI* increases will stop if your cover limit reaches the maximum amount of cover allowed.</p> <p>Your cover limit can be found in the 'who is covered' section.</p>
increase your cover for a special event	<p>A special event allows you to increase your cover with no further questions asked about the insured person's* state of health. We may request supporting evidence of the special event.</p> <p>You qualify for a special event increase for <b>Life Cover, Critical Conditions Cover, and Total and Permanent Disability Cover</b>, if;</p> <ul style="list-style-type: none"> <li>• the insured person* is 59 or younger</li> <li>• your policy has a loading* of no more than 50% because of the insured person's* health</li> <li>• you haven't claimed and aren't eligible to claim under this policy (in other words, you're not planning to claim in the immediate future)</li> <li>• your payments are entirely up to date.</li> </ul> <p>The events we'll cover as a special event are if the insured person*:</p> <ul style="list-style-type: none"> <li>• has had their policy for 5, 10, 15, or 20 years – in which case you can increase your cover within 3 months of the 5th, 10th, 15th or 20th anniversary of this policy, or</li> <li>• has married (including a civil union), divorced or become a parent (through birth or legal adoption*) within the past six months or</li> <li>• has started full-time secondary school or tertiary education for the first time within the past three months, or</li> <li>• takes on the full-time care (for the first time) of a dependent relative* within the past three months, or</li> <li>• is 59 or younger and has taken out or increases a home loan or mortgage. The loan or mortgage must be associated with a residential property. (Loans or mortgages related to commercial premises or to a trust or business don't qualify as a special event) within the past three months, or</li> <li>• has a child, spouse or de facto partner or Civil Union partner who dies or is diagnosed with a Terminal Illness* or has started full-time secondary school or tertiary education for the first time within the past three months.</li> </ul>

For **Income Protection Cover**, you qualify for a special event increase if you request it within 60 days of an insured person's\* income increasing.

- We'll then approve a proportional increase in the cover amount (up to the income replacement percentage you selected) without additional health information.
- You can increase your Income Protection Cover as often as you like, however your cover can't exceed the income replacement percentage you selected or the maximum cover amount.

You cannot take up a special event increase if:

- you have previously claimed or are eligible to claim under this policy, or
- your policy has a loading\* of more than 50% because of the insured person's\* state of health.

What are the limits?

- You're entitled to three special event increases.
- You can have one special event increase per year.
- No single increase can exceed \$250,000 for Life Cover and Total and Permanent Disability Cover or \$100,000 (or 50% of the current value) for Critical Conditions Cover.
- The total of all increases cannot exceed 50% of the insured person's\* original cover.
- Where the special event relates to a mortgage, your increase in cover cannot exceed the amount by which your mortgage has increased.
- There are limits to the maximum cover you can have. Refer to the section 'how much cover you can buy'. If, at any time, you decrease your cover, the limits on increasing your cover for a special event will be recalculated on the new level of your cover.

increase your cover because you want to

You can apply at any time to increase your cover; however, we don't have to approve the increase. Our approval will depend on several factors, including your reason for the increase and the insured person's\* state of health. We'll also need to receive the insured person's\* written consent.

There are limits to the maximum amount of cover you can have. Refer to the section 'how much cover you can buy'.

A 13-month exclusion for suicide will apply to any increase in Life Cover.

If you increase your Critical Conditions Cover, you can't claim on the increased amount for three months.

From time to time, we may approach you with an offer to increase your cover on favourable terms.

decrease your cover

We'll always reduce your cover if you request it. There are no conditions or penalties.

A decrease in your cover will decrease your ongoing payments. This will apply from the next payment due after your request is processed.

Income Protection Cover – change your waiting period

You can apply in writing to change the waiting period on your Income Protection cover, but we are not obliged to agree to a change.

- The change will depend on the insured person's\* state of health and occupation at the time of the request.
- Your options for the waiting period are 30, 60 or 90 days.
- We'll always apply the waiting period that was in place on the day the insured person\* suffered the injury or first sought medical advice for the symptoms of the illness that caused them to become unable to work\*.

Income Protection Cover – change your cover period

You can apply in writing to change the cover period on your Income Protection cover, but we are not obliged to agree to a change.

- The change will depend on the insured person's\* state of health and occupation at the time of the request.
- Your options for the cover period are six, 12, 24 or 36 months.

	<ul style="list-style-type: none"> <li>We'll always apply the cover period that was in place on the day the insured person* suffered the injury or first sought medical advice for the symptoms of the illness that caused them to become unable to work*.</li> </ul>
stop smoking	<p>If the insured person* is currently insured as a smoker*, you can ask to reduce your payments if they stop smoking.</p> <ul style="list-style-type: none"> <li>They must have stopped for 12 months or more.</li> <li>We'll need the insured person* to complete a non-smoking declaration (which you can find on our website) before we can reduce your payments.</li> </ul>
environmental changes	<p>There may be circumstances in which we would need to apply a general increase to payments across all policies: for example, to offset against an increased cancer* trend or other environmental factors. If this occurs, we'll notify you at least 30 days ahead of any increase.</p>
law or tax changes	<p>We can increase your payments to cover any additional costs we incur if the law or tax regulations (or their interpretation) change. If this happens, we'll notify you at least 30 days ahead of any increase.</p>
pass back of changes	<p>If we ever make a change to our policy that's better for you, the new and better version will be added to your policy automatically, subject to:</p> <ul style="list-style-type: none"> <li>If you make a claim, we'll compare the updated part of the policy with your current one and use the one that's better for you. The new version will only apply if your claim happens after the date we made the change.</li> <li>Any special rules or exclusions already in your policy will remain the same, even if other parts improve.</li> <li>If the change means your premiums (what you pay) need to go up, that will happen the next time we review your payments.</li> <li>Once you've chosen this option, you won't be able to change your mind later.</li> </ul>

## Eligibility

### Clarifying who can buy this policy and how much cover they can have

who can buy this policy	<p>This policy can be purchased from Pinnacle Life by any person aged 18 to 74 who permanently resides in New Zealand, Australia, UK, Ireland, USA, Canada, Hong Kong, or Singapore and is:</p> <ul style="list-style-type: none"> <li>a New Zealand citizen or passport holder, or</li> <li>a holder of a New Zealand residency visa, or</li> <li>a holder of a New Zealand work permit for two years or more, or</li> <li>an Australian passport holder living in New Zealand.</li> </ul> <p>To include Critical Conditions Cover, Income Protection Cover or Total and Permanent Disability Cover in this policy, you must be between the ages of 18 and 59 at the time the cover is included.</p> <p>To be eligible for Income Protection Cover, you must also have been in continuous*, full-time*, paid employment in New Zealand for the past two years, either as an employee or a self-employed person.</p>
how much cover you can buy	<p>You can buy as many policies from us as you wish. The maximum amount of cover the insured person* can have cannot exceed:</p> <ul style="list-style-type: none"> <li>\$2.25 million across their Life, Mortgage and Accidental Death Cover policies, with Cover amounts of no more than <ul style="list-style-type: none"> <li>\$1.5 million for Life and/or Mortgage Cover</li> <li>\$1 million Accidental Death Cover and Total Permanent Disability Cover</li> <li>\$625,000 for Critical Conditions, Critical Illness or Serious Illness Cover and</li> </ul> </li> </ul>

- \$15,000 per month Income Protection Cover.
- We'll be liable to pay out only the first \$1.5 million, \$1 million, and \$625,000 respectively if you exceed these amounts without our consent.
- You can only have one Income Protection Cover with us. If you take out a second Income Protection Cover, we'll be liable to pay out only on the first one. Your Income Protection Cover amount can't exceed 75% of your monthly income\*.

## Cancellation

### What happens if you want to cancel your policy

30-day free look	If you change your mind and cancel this policy within 30 days of it first being issued, we'll immediately stop your cover and refund your payments.
cancelling this policy	After the 30-day free look, you can cancel this policy at any time; however, your payments are not refundable. The only exception is where you have paid for either six or 12 months in advance; in this case, we'll refund the amount you have pre-paid.
no cash value	This policy contains no savings or investments and does not share in the profits of Pinnacle Life. The policy has no cash value if cancelled.

### What you need to provide if you need to make a claim and who will receive the money

information we need for all claims	To make a claim, the policy owner or someone acting for them will need to contact us. We'll advise you of the exact requirements for your circumstances at the time of any claim. For all claims, we will need: <ul style="list-style-type: none"> <li>● proof of the insured persons'* date of birth</li> <li>● proof of the owner or beneficiaries'* identity</li> <li>● proof of the bank account you want the claim paid into.</li> </ul>
information we need to assess a death claim	For a <b>Death</b> claim, we'll need: <ul style="list-style-type: none"> <li>● a copy of the insured person's* death certificate, and</li> <li>● a coroner's report if one has been issued.</li> </ul>
information we need to assess a terminal illness claim	For a <b>Terminal Illness</b> claim we'll need: <ul style="list-style-type: none"> <li>● a written opinion from a medical specialist*. This should state: <ul style="list-style-type: none"> <li>○ the nature of the insured person's* illness</li> <li>○ when it was first diagnosed, and</li> <li>○ that they are likely to have 12 months or less to live as a result of this illness.</li> </ul> </li> </ul>
information we need to assess a Critical Conditions claim	For a <b>Critical Conditions</b> claim, we'll need: <ul style="list-style-type: none"> <li>● a written opinion from a medical specialist* confirming that the insured person* has suffered one or more of the Critical Conditions covered under this policy, when it first occurred and/or when it was diagnosed.</li> </ul>
information we need to assess a Total and Permanent Disability claim	For a <b>Total and Permanent Disability</b> claim, we will need a written opinion from a medical specialist* confirming that the insured person* meets one of the criteria of Total and Permanent Disability* covered under this policy, when it first occurred and/or when it was diagnosed. We may also need:

	<ul style="list-style-type: none"> <li>information about the insured person's* employment status from either their employer or their accountant.</li> <li>information about the insured person's* education, training, skills and experience.</li> </ul>
information we need to assess an Income Protection claim	<p>For an <b>Income Protection</b> claim, we will let you know the exact requirements for your circumstances at the time of a claim, but we likely will:</p> <ul style="list-style-type: none"> <li>need details of the illness or injury that has caused the insured person* to become unable to work*,</li> <li>need the names and contact information of all doctors* and medical specialists* who have treated the insured person* concerning those illnesses or injuries,</li> <li>ask for financial evidence of the insured person's* income as well as details of any other income they are either receiving or are entitled to receive while they are unable to work*,</li> <li>need information about the insured person's* employment status from either their employer or their accountant, and</li> </ul> <p>While we are making monthly payments under your Income Protection Cover, the insured person*, at their own cost, will need to provide ongoing medical and financial evidence that is satisfactory to us. You will also need to let us know when the insured person* returns to work.</p>
claiming on other benefits	To claim on the other benefits of your policy, contact our team. We will support you through the process and advise what information we need.
who we pay	<p>You can nominate a beneficiary* to receive the proceeds of any Life, Critical Conditions or Disability claim. If you don't have a beneficiary* or the beneficiary* is deceased, we will pay you, the policy owner.</p> <p>You can nominate an Income Protection beneficiary* to receive the proceeds of any Income Protection claim if you are unable to work*. We'll pay your Income Protection claim to the Income Protection beneficiary or to the Policy Owner if the Income Protection beneficiary is deceased. Your Income Protection beneficiary* does not have to be the same person as any other beneficiary*</p> <p>For information about how to claim on other benefits on your policy, refer to other benefits in the 'Your Life Cover' section.</p>
claiming more than once	<p>If you have both Critical Conditions and Total and Permanent Disability cover, you can claim once on each cover type. The maximum amount we will ever pay under this policy can't exceed the Life Cover amount.</p> <p>Multiple Income Protection claims can be made on this policy however, you can only claim for one claim event at a time.</p> <p>If the illness or injury causing a Income Protection claim is related to (or is a recurrence of) the illness or injury that caused a previous Income Protection claim, then;</p> <ul style="list-style-type: none"> <li>if the insured person* becomes unable to work again within six months the current claim will be treated as a continuation of the previous claim</li> <li>if the insured person* becomes unable to work* again after more than six months, then the claim will be regarded as a new claim and a further waiting period* will apply. In this case, we won't pay a second claim unless the insured person* has been in continuous*, full time*, paid employment in New Zealand for at least 4 months since the previous claim ended.</li> </ul>

<a href="#">our statutory fund</a>	All payment transactions for this policy that we receive from you (or pay to you) will be through our 'Rimu Statutory Fund'. New Zealand law requires us to have a statutory fund to protect your interests by ensuring accounting transparency.
<a href="#">your responsibilities</a>	<p>You must be absolutely truthful with us. We rely on your information to issue your policy and pay any claim.</p> <ul style="list-style-type: none"> <li>• If you are not absolutely truthful or if you don't disclose all relevant information, we may void* or change the terms of your policy.</li> <li>• If your claim includes false or incomplete information we won't be liable to pay any claim and we can, at our discretion, void* your policy.</li> <li>• If, after we pay any claim, we find that it includes false or incomplete information, you must pay back all claim payments.</li> </ul>

## Definitions

### Meanings of words and terms that we have used in this document

<a href="#">accidental death</a>	A person's death is accidental if they die within 180 days of sustaining an injury that caused their death. External, violent and accidental means must cause the injury, directly and solely. Suicide or a self-inflicted injury that results in death is not considered accidental.
<a href="#">activities of daily living</a>	<p>An activity of daily living is one of the following:</p> <ul style="list-style-type: none"> <li>• Moving to, from and within a bed, chair or wheelchair, or moving from place to place by walking, using a wheelchair or with the help of a walking aid</li> <li>• Dressing and undressing (including grooming and fitting with artificial limbs)</li> <li>• Bathing and showering</li> <li>• Eating and drinking</li> <li>• Using a toilet for normal personal hygiene</li> </ul>
<a href="#">beneficiary</a>	<p>This beneficiary is the person to whom we'll pay a Life, Critical Conditions, or Total and Permanent Disability claim. When your policy is first issued, you, the policy owner, are automatically nominated as the beneficiary. You can change the beneficiary to someone else; see the section entitled 'change beneficiary'.</p> <p>The beneficiary can only be a natural person and must be over the age of 18.</p> <p>If the beneficiary is deceased, the policy owner automatically becomes the beneficiary.</p>
<a href="#">Consumer Price Index (CPI)</a>	The CPI is an index published by Statistics New Zealand. We use the results published for September.
<a href="#">dependent relative</a>	A dependent relative could be the mother, father, brother, sister, son, daughter, father-in-law, mother-in-law, grandfather, grandmother, grandchild, spouse, de facto partner, or Civil Union

partner. We'll include other relatives if you can show a relationship exists that is the same as one of the relationships above (e.g. Whāngai).

<b>doctor</b>	<p>This means a doctor or medical practitioner licensed to practice medicine legally within New Zealand.</p> <p>For the purposes of this policy, a doctor can't be you or the insured person*, or any relation, business associate, employer or employee of you or the insured person*.</p>
<b>insured person</b>	An insured person is a person whose life or health is covered under this policy.
<b>legally adopted</b>	Legally adopted means subject to an adoption order under the Adoption Act 1955 or an overseas adoption order which is outlined in section 17 of that Act.
<b>loading</b>	A loading is when we charge a higher premium to cover the insured person*.
<b>medical specialist</b>	<p>A medical specialist means a practising medical specialist, who is licensed to practise his or her medical specialty within New Zealand, Australia, UK, Ireland, USA, Canada, Hong Kong or Singapore. Their specialty qualifies him or her to make a prognosis related to the terminal illness or to diagnose a medical condition, illness, disability or injury covered under this policy of an insured person*.</p> <p>For the purposes of this policy, a medical specialist can't be you or the life insured, or any relation, business associate, employer or employee of you or the life insured.</p>
<b>smoker/non-smoker</b>	If an insured person* has smoked a cigarette or any other substance during the last 12 months or has used a vape or electronic cigarette, they're a smoker. If not, they're a non-smoker*.
<b>void</b>	If we void your policy, we'll consider that your policy has never existed, payments you have made will not be refunded and we will not pay any claims.
<b>we, our, us</b>	We, our or us means Pinnacle Life.
<b>you, your</b>	You or your means the policy owner.

## Income Protection Definitions

<b>ACC</b>	The Accident Compensation Corporation (ACC) is the Crown organisation in New Zealand that provides comprehensive, no-fault personal injury cover for all New Zealand residents, as well as visitors to New Zealand.
<b>annual income</b>	<p>If the insured person* is an employee, annual income* means their highest gross taxable annual income coming directly and solely from engaging in their usual occupation*, measured over a 12-month period in the two years immediately prior to their becoming unable to work*.</p> <p>If the insured person* is self-employed, then all tax returns due before they became unable to work* must be filed before a claim can be made. Annual income* will then mean their gross taxable annual income derived directly and solely from engaging in their usual occupation* as reported to the IRD for the most recent period before they became unable to work*.</p>
<b>continuous employment</b>	If the insured person* has been in continuous employment, it means they have been employed without a break during the past two years (where annual leave or other paid leave is not counted as a break). If the insured person* changed jobs or moved to a different company within the past two years, we will still regard their employment as 'continuous' provided that they have not changed jobs more than three times during this period and that no period between jobs exceeded 30 days.



cover limit	<p>Cover limit means the maximum amount we'll ever pay for an Income Protection claim.</p> <p>When covering 40% of the insured person's* monthly income*, our cover limit is \$8,000 per month if the insured person* is aged 20 to 50, \$6,670 per month if they are aged 51 to 54 and \$5,340 per month if they're aged 55 to 65.</p> <p>When covering 60% of the insured person's* monthly income*, our cover limit is \$12,000 per month if the insured person* is aged 20 to 50, \$10,000 per month if they are aged 51 to 54 and \$8,000 per month if they're aged 55 to 65.</p> <p>When covering 75% of the insured person's* monthly income*, our cover limit is \$15,000 per month if the insured person* is aged 20 to 50, \$12,500 per month if they are aged 51 to 54 and \$10,000 per month if they are aged 55 to 65.</p>
full-time employment	<p>If an insured person* is in full-time employment, it means they are working, on average, at least 30 hours per week. This doesn't need to be with a single employer.</p>
Income Protection beneficiary	<p>The Income Protection beneficiary is the person to whom we'll pay an Income Protection claim if the insured person* becomes unable to work*. When your policy is first issued, you the policy owner*, are automatically nominated as the Income Protection beneficiary. However, you can change the Income Protection beneficiary to be someone else; see the section entitled 'change Income Protection beneficiary*'. </p>
mental illness	<p>A mental illness means any psychiatric, psychosomatic, mental or nervous condition, including, but not limited to, depression, anxiety, stress, post-traumatic stress, psychoneurosis, psychosis, emotional or behavioural disorders, disorders related to substance abuse and dependency, which includes alcohol, drugs or chemical dependency, chronic fatigue or other psychological or psychiatric disorders or the side effects of the treatment for such conditions.</p>
monthly income	<p>Monthly income means one twelfth of the insured person's* annual income*.</p>
redundant or redundancy	<p>The insured person* is redundant if their employer has disestablished their position and, because of this disestablishment, they have remained unemployed for at least 30 consecutive days.</p>
unable to work	<p>If the insured person* is unable to work, it means a doctor* has confirmed that, solely because of an illness or injury, the insured person*:</p> <ul style="list-style-type: none"> <li>• is unable to perform all of the duties of their usual occupation* for more than 10 hours per week, and</li> <li>• is not currently engaged in their usual occupation* or any other paid work whatsoever, and</li> <li>• is following the advice of a doctor* or medical specialist* in relation to the illness or injury for which they are claiming.</li> </ul> <p>Pinnacle Life, at its sole discretion, can seek a second opinion from a doctor* or medical specialist* of its choice to confirm (or otherwise) the prognosis of being unable to work.</p>
usual occupation	<p>The usual occupation means the occupation (or occupations) that the insured person* was employed in for at least 30 hours per week, and received an income from, immediately prior to their becoming unable to work*. If they were unemployed when they became unable to work* (for any reason), then their usual occupation will be determined as follows:</p> <ul style="list-style-type: none"> <li>• If they were unemployed for six months or less prior to becoming unable to work*, their usual occupation is the occupation they were engaged in immediately prior to their unemployment.</li> <li>• If they were unemployed for more than six months (for any reason) prior to becoming unable to work*, they will be considered to have no usual occupation and will not be entitled to claim.</li> </ul>

## Critical Conditions Definitions

<p>accidental HIV infection (medically or occupationally acquired)</p>	<p>A confirmed diagnosis of Human Immunodeficiency Virus (HIV) resulting from:</p> <ul style="list-style-type: none"> <li>• The accidental or violent transmission of the virus during the course of the life insured person's* normal occupation or</li> <li>• through one of the following medical procedures performed in New Zealand by a registered health professional. <ul style="list-style-type: none"> <li>◦ a transfusion of blood or blood products;</li> <li>◦ an organ transplant where the insured person* was the recipient;</li> <li>◦ assisted reproductive techniques; or</li> <li>◦ other medical procedure or operation performed by a Medical Practitioner/Paramedical Practitioner or Dentist at a registered medical facility</li> </ul> </li> </ul> <p>We require a statement from an appropriate medical specialist* that provides documented proof of the incident and confirms that the infection is medically or occupationally acquired.</p> <p>Proof of a new HIV infection (sero-conversion) must be registered within six months of the accident or violent act and be supported by a negative HIV test taken within ten days of the incident.</p> <p>Any incident giving rise to a potential claim must be reported to the relevant authority or employer. We encourage you to report any incident giving rise to a potential claim to us within 30 days.</p> <p>The definition will not be met if:</p> <ul style="list-style-type: none"> <li>• the New Zealand government or relevant government body has approved a medical treatment or cure which renders the virus inactive and non-infectious</li> <li>• the infection arises from a deliberate, self-inflicted or induced cause, or from sexual activity (whether as part of your occupational duties or otherwise), or from the use of drugs not medically prescribed to you</li> <li>• in practising your own occupation, you have not made reasonable efforts to comply with any New Zealand Government guidelines in relation to preventing infection of health care workers; or you have not taken an approved vaccine that is recommended by the relevant government body for use in your own occupation and is available prior to the event which causes infection.</li> </ul>
<p>advanced diabetes (with at least one complication of specified severity)</p>	<p>Means an appropriate medical specialist* has confirmed that at least one of the following complications have occurred as a direct result of diabetes:</p> <ul style="list-style-type: none"> <li>• Severe diabetic retinopathy resulting in visual acuity (whether aided or unaided) and corrected of 6/36 or worse in both eyes; or</li> <li>• Severe diabetic neuropathy causing motor and/or autonomic impairment; or</li> <li>• Diabetic gangrene leading to the surgical removal of a whole hand or whole foot; or</li> <li>• Severe diabetic nephropathy causing chronic irreversible renal impairment as measured by an estimated glomerular filtration rate less than 30 mL/min/1.73m<sup>2</sup> (CKD stage 4, International Chronic Kidney Disease classification).</li> </ul>
<p>Alzheimer's disease</p>	<p>Means the unequivocal diagnosis of Alzheimer's disease by an appropriate medical specialist*.</p>
<p>aplastic anaemia</p>	<p>Bone marrow failure that results in anaemia, neutropaenia and thrombocytopenia; and that requires treatment with at least one of the following:</p> <ul style="list-style-type: none"> <li>• Blood product transfusion, or</li> <li>• Marrow stimulating agents, or</li> <li>• Immunosuppressive agents, or</li> <li>• Bone marrow transplantation.</li> </ul>

<p>benign tumour of the brain or spinal cord (with permanent neurological impairment or requiring specified treatment)</p>	<p>A non-cancerous tumour in the brain or spinal cord that results in neurological damage and functional impairment which an appropriate medical specialist* considers to be permanent; or requires removal through surgery.</p> <p>This excludes cysts, granulomas, cholesteatomas, malformations in or of the arteries of the brain, haematomas, and tumours on the pituitary gland.</p> <p>The underlying tumour must be confirmed by imaging studies such as a CT scan or MRI.</p>
<p>blindness (severe and permanent)</p>	<p>The severe and irreversible loss of sight in both eyes, whether aided or unaided to the extent that:</p> <ul style="list-style-type: none"> <li>• visual acuity is less than 6/60 in both eyes after correction, or</li> <li>• field of vision is reduced to 20 degrees or less of arc, or</li> <li>• a combination of visual defects resulting in the same degree of visual impairment as either blindness definition above.</li> </ul>
